Tough new legislation targets properties used for illegal activities *Safer Communities and Neighbourhoods Act provides tool to improve safety*

Edmonton... Albertans now have a new tool to combat illegal activities associated with gangs, drugs and prostitution in their neighbourhoods. The *Safer Communities and Neighbourhoods (SCAN) Act*, which comes into force October 1, creates a new sheriffs' unit to investigate public complaints about properties used for illegal activities and, if necessary, close those properties for up to 90 days.

"The SCAN investigative unit gives Albertans another tool to help deal with the crime and disturbances that devastate our neighbourhoods," said Fred Lindsay, Solicitor General and Minister of Public Security. "The act helps engage community members as partners with government and law enforcement in creating safe and secure communities."

SCAN responds to a recommendation from the Crime Reduction and Safe Communities Task Force Report to adopt the act and make communities safer. "Alberta's communities may be growing and changing, but they still maintain the fundamental principles that make Albertans who and what they are -caring, respectful citizens who take pride in their communities. This Act gives Alberta communities one more tool to fight crime and promote quality of life," said Alison Redford, Minister of Justice and Attorney General.

Modeled after similar civil legislation in Saskatchewan, the act enables the SCAN investigative unit to mediate, investigate or apply to the courts for a Community Safety Order that requires individuals to vacate and/or close the property. Any criminal activity uncovered when dealing with these properties will be turned over to the police to investigate.

For the first year, two SCAN teams will serve the province with a northern team based in Edmonton and a southern one based in Calgary. In subsequent years regional offices may be set up in smaller centres throughout the province.

Landlords or neighbours who are concerned tenants or residents may be using property for illegal activities that negatively affect the health, safety and security of a neighbourhood or community can report a problem property by phoning the SCAN unit's toll-free number at 1-866-960-SCAN (1-866-960-7226). An online complaint can also be filed at www.scan.alberta.ca.

Backgrounder

Safer Communities and Neighbourhoods (SCAN) Act - Questions And Answers

What is SCAN legislation about?

- The act will improve community safety by targeting and, if necessary, shutting down residential and commercial buildings regularly used for illegal activities such as producing, selling, or using illegal drugs, prostitution, solvent abuse, the unlawful sale and consumption of alcohol, gang activity, organized crime or the exploitation of children.
- SCAN focuses on how the activity affects the neighbourhood and community, not on the activity itself. It focuses on whether the activity negatively affects the health, safety or security of one or more persons in a neighbourhood; and/or if it interferes with the peaceful enjoyment of one or more properties in a community or neighbourhood.

- Because SCAN is civil legislation, the test in court is "balance of probabilities" as opposed to criminal law, in which the test is "beyond a reasonable doubt."

What does SCAN do?

- In response to a public complaint, SCAN investigates a property that appears to be used for illegal activities, and can close it down if necessary. SCAN investigators can obtain court orders to make property owners take responsibility for the activities occurring on their property.

How does SCAN operate?

- When a concerned resident makes a complaint to SCAN, the unit will begin an investigation.

Safer Communities and Neighbourhoods (SCAN) Act - Questions And Answers

- Investigators will first meet with a property owner to try to solve the problem, or send a warning letter to the property owner, landlord, or the person who lives at the property.
- If necessary, SCAN will apply to the Court of Queen's Bench for a Community Safety Order. This is a court order that prohibits all persons from causing, contributing to, permitting, or agreeing to the specified activities. If necessary, the order can close the property for a period of up to 90 days.
- Any criminal activity uncovered when dealing with these properties will be turned over to the police.

Are complaints confidential?

- All complaints are confidential. The identity of those who file complaints will not be revealed at any time.

What happens if a Community Safety Order is issued for a property?

- A copy of the order is posted on the property and served on the owner. The order will require the owner to take steps to stop the activity, and prevent tenants from continuing any illegal activities at the property. It may order some or all of the tenants to leave if they have been involved in those illegal activities.

What happens to occupants living in a property being investigated by SCAN?

- SCAN's goal is to improve community safety. Tenants are only removed from a residence as a last resort, and if there is no cooperation from the tenant or the owner.
- If a Community Safety Order is obtained, all occupants of a property can be ordered to leave immediately. No one may re-enter the property without the consent of the SCAN unit or the court.

What happens to tenants who are not involved in illegal activities?

- The act permits the director of law enforcement to allow others to access a property that is closed by a Community Safety Order. Tenants who are not involved in illegal activities may be permitted to remain on the property.

Who makes up the SCAN unit and where will they be located?

- Initially, each team will have seven SCAN investigators appointed as Alberta sheriffs. The unit will also include a deputy director, two regional managers and two analysts.
- For the first year, two SCAN teams will serve the province with a northern team based in Edmonton and a southern one based in Calgary.
- SCAN investigators have completed an intensive seven-week training course and will continue to receive ongoing training

as required. Many of the investigators are former police officers with extensive investigative experience and the others are newly hired sheriffs.

- In subsequent years, regional offices may be set up in smaller centres throughout the province. This will be determined by need.

How much does SCAN cost?

- About \$4 million in annual funding is required to meet the needs of the new program.

When will SCAN operate in rural areas?

- SCAN is expected to do some investigations outside Edmonton and Calgary during the first year of operation. Expansion into rural areas may occur in subsequent years.

How will SCAN support police?

- The police are responsible for enforcing the Criminal Code and Controlled Drugs and Substances Act. These pieces of legislation deal directly with the offender and the behaviour, not the property where the criminal behaviour is occurring.
- SCAN will assist the police in dealing with the problem property. Illegal activities will be removed from the community and a safer neighbourhood is created for the families who live there.
- SCAN investigators will also provide information to police that they may need in order to get a criminal warrant. Using this collaborative approach involving police and SCAN, the result will be safer neighbourhoods and communities.

How will SCAN support landlords?

- SCAN will help landlords remove problem tenants who disrupt neighbourhoods, destroy property, and bring property values down. SCAN holds landlords responsible for the activities taking place on their properties that affect the entire neighbourhood. It also empowers landlords to remove problem tenants.

Who is responsible for costs incurred when a property is shut down?

- SCAN will initially pay for the costs of closing and managing a property while it is closed, but landlords will be billed the property management costs, such as security services to monitor the residence while it is closed.

320 Words Recognizing the Good Ones

Law-abiding citizens have nothing to fear if they see by-law officer Bev Bentley walking towards them – and it might be worth sticking around to say hello.

Hinton's bylaw service has just launched their Caught In The Act (CITA) program, through which Hintonites can be awarded for doing things right, instead of being ticketed for doing things wrong.

"I have always got those gut feelings when I see people doing something right that they should get something for it," said Bentley.

Bylaw services have partnered with local businesses and the Town of Hinton to provide certificates to hand out to citizens who are caught obeying the law. Bentley said he is looking for people who have gone above and beyond what is just required.

"The CITA program was designed to recognize those that adhere to the municipal laws, as well as safety programs," he said.

Bentley said that he runs into a lot of cases where people have gone the extra step.

"Everybody likes to be recognized for doing something right," he said.

The first winners of the CAIT program were Samuel Fafard and Stephane Briand, crossing guards at Mountain View School. Bentley said he picked the patrol program at Mountain View School because the school took the initiative to address the speeding problem on MacLeod Avenue by putting out signs in the street.

Along with aiming to improve the town, Bentley said he hopes to build a better relationship with the community.

"Hopefully it will help rid the negative attitude that the town has towards bylaw officers," he said. "In our job, we affect a lot of personal belongings through bylaw – it's a very sensitive job."

He said the program was also designed to raise public awareness about the bylaw officer's job.

Bentley said that at the start of the program, he might have problems approaching people to give them their certificates.

"People always think I'm coming to nail them," said Bentley. "This will be a pleasant surprise."

Animal Control Committee Report

The Animal Control Committee has been working hard since putting on the first ever Introduction to Animal Control course at the May conference. A total of 70 AMEA members attend the two day course to take advantage of the speakers which included Dr. Wilkinson as well as animal control officers who offered a wide range of experience and expertise.

In the past couple of months the Animal Control Committee has undergone a change with John Wilson stepping down from the position of Committee Chair and Becky Oxtan accepting the interim position. With John Wilson completing his eight year term on the Executive he is ineligible for re-election therefore at the February AGM a new Education Officer will be elected onto the Executive team. The Animal Control Committee decided that the upcoming Committee Chair is best suitably filled by the next Education Officer. In February the Animal Control Committee will also be looking to the membership for new members to serve on the committee. If you are looking for an opportunity to contribute to animal control officers throughout the Province this may be the perfect time.

Upcoming Training

The Animal Control Committee has been striving hard to conduct a follow up course to the Introduction to Animal Control and is pleased to announce the two day Animal Aggression Investigations Course presented by Jim Crosby. Currently Jim Crosby is serving as the Director of

Animal Control for Bay County, Florida. Jim also presents training seminars for Animal Control Officers, Police Officers, Prosecuting Attorneys and others establishing procedures and standards for serious and fatal dog bite investigations. Retired Police Lieutenant and professional dog trainer Jim Crosby has invaluable experience and extensive insight to bring to the problem of dog attacks and dangerous dog problems. Jim has consulted with Animal Control Authorities, Prosecutors, Attorneys and others on serious and fatal dog attacks, providing detailed behavioral analysis of the incidents. As Jim states; "For criminal prosecution, the testimony of a skilled expert may make the difference between justice and miscarriage. In civil cases, proper, professional assessment of the incident replaces emotion with sound, rational evaluation." Jim also provides investigative protocols as well as an investigative checklist to assist animal control officers in conducting aggressive animal investigation.
